# WEST NILE VIRUS UPDATE

The Wyoming Department of Agriculture Emergency Insect Management Committee met on April 20, 2004 to decide the fate of much of the money in its budget. At least 31 agencies/communities had applied for emergency bug control grant monies. Of those agencies, most asked for mosquito grant money, and 2 applied for grasshopper grant money. The panel approved 28 of these applications for the strengthening of local mosquito and grasshopper control programs. Because of the number of grant applications that were approved, the committee has already depleted most of its funding by giving away more than \$1.2 million of its \$1.69 million from its biennium budget. The grant money will be given to local officials' right away, as mosquito season is already well underway. Because the future of the disease and its impact in our state is unknown at this point, more money may be needed by next season for mosquito control programs throughout Wyoming. It will be determined by the 2005 legislative session, whether or not this funding will be provided or not.

# Outbreak of Gastrointestinal Illness Associated With Events at a Hotel in Cheyenne Excerpted from Infectious Disease Report March 2004

In late February, the City of Cheyenne-Laramie County Health Department and the WDH began investigating an outbreak of gastrointestinal illness among people who had recently attended functions at a Cheyenne hotel. Initial case finding and data gathering revealed that 124 people with illness that may have been associated with this outbreak. A case-control study was conducted which included 209 people, consisting of 107 cases and 102 controls. Diarrhea was present in 101 (95.3%) and vomiting in (63.8%) of the cases. The date of onset ranged from 2/20 to 2/27, with 66% having a date of onset of either 2/24 or 2/25. The median duration of the illness was 2 days (range <24 hours to >5 days).

Exposures that were found to be statistically associated with increased odds of illness were eating at least one meal or snack that was prepared or served by the hotel (OR 7.7, 95% Cl 1.7-34.9), and drinking a beverage from the hotel bar (OR 2.4, 95% Cl 1.4 – 4.2). All 15 stool specimens that underwent bacterial culture were negative for bacterial enteric pathogens. Seven stool specimens underwent testing for human calicivirus (Norovirus), and 6 were positive (3 hotel patrons and 3 hotel employees).

#### Wyoming Food Safety Coalition Announcements:

The Wyoming Food Safety Coalition convened on May 3, 2004 for it's 2<sup>nd</sup> quarterly meeting of the year. During the meeting a couple of decisions were made in regards to ServSafe. First, since costs for the course materials continue to rise, it was decided that an increase in price was necessary in order to recoup some of the associated expenditures. It was decided during the meeting to raise the price from \$100 to \$127 for the course. Any newly scheduled ServSafe courses will be collecting this rate. Secondly, it was decided to approve a One-Day ServSafe Recertification Class. The class will not be designed for those people who have never taken a ServSafe course, but strictly for those

who have taken the class in the last five years and are due to be recertified.


